

A Greener Place to Live Can Start in West Walker

It has taken me a while to gather my thoughts to write this column. I'm so excited to be involved in environmental issues in the neighborhood! I have been interested in the environment for a long time, and have been following the story of global warming with keen interest.

It is easy to become overwhelmed by the sheer scale of the issue, and say to oneself "I'm just one person – what can I really do?" Well, the answer is, quite a lot! If everyone does a few things, it can amount to a whole lot of action!

Every journey starts with one small step. So, when I started thinking about writing a monthly column for the Wire, I realized I couldn't solve all the environmental problems in one issue, but that I would start with one small step. Also, let me say I would never ask anyone to do something I haven't done myself – so, let me tell you about a few of the things I have done at my own home. Here's just a quick list of what I've accomplished since moving into West Walker in 2006.



- Had a stainless steel liner installed in my chimney
- Installed Solar panels for heat and hot water which generate most, if not all, of my hot water in the summer, and about 35% in the winter (also contributing to lessening my gas usage for heat).
- Started a vegetable garden and planted dwarf fruit trees
- Added some edible ornamentals – hardy fig, hardy kiwi, grape, blackcurrant and gooseberry, along with herbs amongst my regular perennials
- Used the "Lasagne Gardening" method in my front yard to grow annuals, perennials and edible plants. Also cleared an area on the parkway with this method (creating greenery without having to cut the lawn!)

If you are interested in more information on any of the projects I have undertaken, I'd be happy to talk to you about them (We may even feature them in future editions of the Wire).

So, where to start on the Environmental Committee?

Well, recycling is important – I use the blue bags, but look forward to getting a blue bin instead, and will be following the progress of the pilot with the Alderman's office.

Also, my basement flooded twice this year, in June and August. So I think it's important to be working with Tom LaPorte from the Department of Water Management on initiatives which will help reduce the impact of big thunderstorms on our neighborhood. I rerouted one downspout on the side of my house into a rain barrel, which enables me to store water for garden use. Tom LaPorte is willing to have someone come to your home to evaluate whether you can do this also.

I'd welcome your thoughts and suggestions regarding environmental issues, and anyone willing to help on the committee with implementing neighborhood projects.

Looking forward to working with you!

West Walker Needs Your Help!

Two key volunteer positions are open within our organization. These jobs are essential to keeping our neighborhood informed and our gathering space ready for the monthly meetings. Both require a monthly commitment – but the time is relatively minimal.

Wire Carrier Coordinator

This position requires approximately a 2 hour per month commitment. One hour is for counting and sorting copies of the Wire for distribution to the Carriers (who will then deliver the newsletter in the neighborhood). The distribution to the carriers means going to between 14-16 homes in the neighborhood, (taking less than an hour by car, a bit more on foot). The Wire Carrier Coordinator is also responsible for recruiting new carriers if any are unable to continue to deliver.

Monthly Meeting Set Up/Break Down Coordinator(s)

Help ready our space before the monthly WWCA General meetings. This volunteer position requires arriving to the Latvian Hall at approximately 7:00 p.m. to unlock the building, set up chairs and a couple of tables. The meeting coordinator is also responsible for break down at the close of the meeting, putting chairs/tables away and any cleanup (minimal) of garbage. Keep in mind that most times others will be around to assist you. But we need someone to be the go to person for this job just in case others aren't around to help.

Keep in mind - this job could be shared between two volunteers (one to set up and one to break down), so maybe this is something you and a neighbor would consider taking on together!

If you've wanted to get involved with WWCA but were worried you didn't have a lot of time to give – these jobs could be for you! Contact any of the Officers or Board Members for more details or to volunteer.

WWCA – General Meeting Minutes – October 16, 2007 – 26 present

WWCA President Liz Mills opened the meeting at 7:35 pm.

New WWCA Board Members, Margaret McIntyre and Pam Maremont, were announced and welcomed.

The September General Meeting Minutes were approved.

Treasurer Bob Begeske reported a general account balance of \$1,850.00. The current Banner Account balance is \$3,628.68.

Ashley Bush and Jonathon Hymen of the recently relocated LaCosta Theatre Company were on hand to introduce their Company to the neighborhood. The theatre company, located at 3931 North Elston, has opened its first run, with more plays planned. For play information, go to www.lacostatheatre.com. The group plans for a variety of community outreach programs, including classes, play readings and a summer children's camp. The theater may also host additional events such as gallery openings and productions by other theater groups. Discount pricing on shows is available for local residents and further details are available on the web site or at the box office.

Also present was Falon Mihalic of the Healthy Streets Campaign. Healthy Streets is a pilot program aimed at reducing automobile accidents, injuries and fatalities within a targeted area bounded by Montrose, Fullerton, Kedzie and Austin. In 2005, 9,034 crashes were reported within that area, for an average of 25 crashes per day. Healthy Street's goal is to reduce that statistic by 50%. They will be attempting to employ street design changes, increased and targeted traffic enforcement and awareness advertising to achieve this goal. Further information is available at www.healthystreets.org.

The Vision Committee will soon launch an artistic series titled Art in My Backyard. The series will feature varied artistic events starting in early 2008. These events will take place as the search for a West Walker Cultural Anchor continues.

Mike Webber reported that the Chicago Committee on Zoning approved the variance on the 4154 N. Elston property, purchase on the property has been completed and the WWCA Zoning Committee is evaluating final plans for the buildings.

Voting has been completed for the Independence Park Bungalow as part of the American Express and The National Trust for Historic Preservation "Partners in Preservation" which will distribute \$1 million to protect significant local architecture. Grants are to be announced November 13, 2007.

In CAPS, increased numbers of burglaries have been occurring in the neighborhood. Police believe the general increase in affluence of the neighborhood has attracted thieves. Keep your property secure at all times. Also, when calling 311 or 911 for any reason, remember that the more detail provided, the better able the City and Police will be able to respond.

The Stripp Joynt, located at 4170 North Elston, has ceased operations pending further review by the City of Chicago Department of the Environment.

The sudden opening of a Car Wash at Elston and Harding is being investigated for proper zoning and permits.

A new Wire Coordinator, whose primary responsibility is to ensure delivery of the Wire to all carriers, is needed. Anyone interested should approach any WWCA Board Officer or Board Member.

Michelle Kaicener is coordinating recycling efforts. Keep an eye on www.bluecartschicago.com for the latest on the new City recycling program.

The meeting was adjourned by President, Liz Mills.

CAPS Report

While burglary is not the top crime this month it is still in the top three and this past month I experienced it first hand. After the Wire went to press in October we learned that a resident's car had been ransacked while parked in the garage. On October 28, sometime after 11:30 p.m., two garages in the 4200 block of N. Hamlin were also entered and several items were stolen from both the cars and the garages. It is still unclear how the criminals got into the garages, but it appears that they used a garbage can to climb onto the roof and entered through the access door. Once inside, they rifled through the cars, stealing such things as CDs, car manuals and cell phone accessories. Some tools were also stolen and they exited through the main door. The officers of beat 1723 still stress how important it is to lock your windows and doors, especially when you are not home.

While no one wants to be the victim of a crime, we have decided to use this opportunity to reach out to some of our neighbors. Introduce yourself to the neighbor across the alley, exchange phone numbers with your neighbor on the corner and let the new family on the block know that they are part of a community. The more you communicate and keep a watch out on your block the less likely crime will spread.

The October CAPS meeting included two presenters, one from the Tactical Gang Team and a representative from the 911 call center. Most of the discussion centered around 911 and how calls are handled and then officers dispatched. Once a call comes in it is given a priority number (1-3), priority 1 being the potential for loss of life. The calls are then routed to the appropriate service (police, fire or medical) and the nearest station. You can follow up on a 911 call you have made by calling 911 back and asking to speak with a supervisor. They are limited by some of the information they can share, but you should be able to find out some details.

The ice cream truck mentioned in the last month's report has been permanently parked and the driver was arrested.

I hope everyone enjoys a very pleasant and safe Thanksgiving! And even though the snow will soon begin to fall, our neighborhood parks are still as active as ever. **The Chicago Park District** has enough activities to keep everyone busy well into the new year. Information about the parks' winter programs is available now online at www.chicagoparkdistrict.com. Program sessions run the weeks of Monday, January 7 through Sunday, March 23, and online registration begins Monday, November 26 at 9:00 a.m. In-person registration at most parks begins Saturday, December 1 (confirm date with your local park). Online registration ends Sunday, January 6, 2008, so get online today and decide what programs interest you.

The cold weather is here to stay, and flu season is upon us. I strongly encourage senior citizens, those with chronic illnesses, and young children to receive influenza vaccinations. And in addition to receiving a flu shot, the **Chicago Department of Public Health** recommends you take the following steps to better your chances of staying healthy this flu season:

- Avoid direct contact with infected persons or contaminated surfaces.
- Wash your hands frequently with soap and warm water, especially before you eat and after you use the bathroom.
- Make an extra effort to clean commonly touched surfaces.
- Do not share anything that goes in the mouth.
- Eat more whole grain, vegetables, and fruit. Get enough rest and exercise.
- Do not smoke, and reduce your exposure to secondhand smoke.
- If you have the flu or a cold, cover your nose and mouth when you cough and sneeze, and promptly discard all used tissues.



Office Report: 40th District



Senior Citizen Exemption

The senior citizen exemption may entitle Cook County property owners, aged 65 and over, to a reduction in property taxes. This exemption entitles qualified senior citizens to a reduction of \$3,500 in the equalized assessed value (EAV) of their properties, resulting in significant tax savings.

To qualify for the Senior Citizen Exemption for the taxable year 2006 the property owner must meet the following requirements:

- Be born prior to or in the year 1941
- Own the property during 2006
- (If a property owner takes residence after January 1, he or she may receive a prorated exemption based on the month the property was purchased.)
- Use the property as principle place of residence

Senior citizens qualifying for this exemption will automatically receive the Homeowners Exemption. These two exemptions combined may result in hundreds of dollars in reduced property taxes. Taxpayers must file each year in order to continue to receive the Senior Citizens Exemption.

Those tax payers who have received the Senior Citizens Exemption in the past should automatically receive a tax payer exemption mailing each year. Applications must be completed and returned to the Cook County Assessor's Office as soon as possible. Tax payers, who do not automatically receive a mailing by May 1st, should contact the Cook County Assessor's Office at 312-443-7550.

Senior Freeze Exemption

In addition to the Senior Citizen Exemption, seniors on limited incomes may also qualify for another valuable exemption. The Senior Freeze Exemption allows qualified senior citizens to apply for a freeze of the equalized assessed value (EAV) of their properties.

This exemption freezes the equalized assessed value at the level prior to the taxable year of which the applicant first applies and qualifies. For example, a senior citizen who applies and qualifies for this exemption in the taxable year 2006 will have the EAV of the property frozen at the 2005 level.

Those receiving this exemption should be aware that this does not automatically freeze the tax bill amount. Only the EAV remains at the fixed amount. The budget that each taxing district approves and the resulting tax rate will continue to affect the calculation of tax bills.

Tax payers having additional questions regarding the Senior Freeze Exemption should contact the Assessor's Office at 312-443-7550. State law requires that tax payers file applications each year in order to continue to receive the Senior Freeze Exemption. 
